### Answer all the questions.

1 The graph of  $y = 3.15x^3 + 0.75x^2 - 5.2x + 2.2$  is shown in Fig. 1.1.

There are three roots to the equation  $3.15x^3 + 0.75x^2 - 5.2x + 2.2 = 0$ , a repeated root,  $\alpha$ , and  $\beta$ , where  $\alpha > \beta$ .

(a) Explain why the bisection method cannot be used successfully to find  $\alpha$ . [1]

The bisection method is used to find the value of  $\beta$  using a spreadsheet. The output is shown in Fig. 1.2.

- (b) Use the information in Fig. 1.2 to find the value of  $\beta$  as accurately as you can. [1]
- (c) Deduce the maximum possible error in your answer to part (b).

The formula in cell A3 is as follows.

### =IF(F2 < 0, E2, A2)

(d) Write down a similar formula for cell C3.

The Newton-Raphson method is used to find  $\alpha$ . The spreadsheet output, together with some further analysis, is shown in Fig. 1.3. The iterates are shown in column L, the difference between successive iterates is shown in column M and the ratio of successive differences is shown in column N.

  - (i) cell M3,

- (f) State what the values in column N tell you about the convergence of the sequence of estimates for  $\alpha$  in column L, stating what is unusual about this. [2]
- 2 You are given that  $f(x) = \log_{10}(2x+1)$ .

(ii) cell N4.

- (a) Calculate the absolute error when f(5) is used to approximate f(4.98). [2]
- (b) Hence find an approximation to f'(4.98). [2]
- (c) Use the central difference method with h = 0.02, h = 0.01 and h = 0.005 to find three estimates of f'(4.98). [3]
- (d) Without doing any further calculation, state the value of f'(4.98) to an accuracy which seems justified. [1]
- **3** Sallysavers Building Society offers a "Bigsaver" account. Interest is payable at the end of each year. The rate of interest is 2.33% per annum.

A customer models the situation by assuming that interest earned is rounded to the nearest penny. This customer invests £375 at the start of the year.

(a) Use this model to calculate the amount of interest earned on the customer's investment after one year.

In fact, the interest earned is not rounded to the nearest penny. Instead, the interest paid to each "Bigsaver" account is chopped to the nearest penny. There are 12254 "Bigsaver" accounts, in which a range of amounts have been invested.

(b) Stating the modelling assumption made, calculate an estimate of how much money in total the building society saves in interest payments over one year by chopping instead of rounding the interest payments on "Bigsaver" accounts. [3]

At Sallysavers there are 534220 additional accounts on which interest is paid at the end of each year.

- (c) Use the modelling assumption in part (b) to calculate an estimate of how much money the building society saves in interest payments over one year to these additional accounts by chopping the interest paid to the nearest penny. [1]
- (d) State whether your answer to part (c) is more reliable or less reliable than your answer to part (b), explaining your reasoning. [1]

(a) In order to calculate an estimate of  $\int_0^1 (0.8x)^x dx$  using a numerical method it is necessary to make an important assumption. State this assumption. [1]

Some estimates of  $\int_0^1 (0.8x)^x dx$  have been calculated using the midpoint rule, denoted by  $M_n$ , trapezium rule, denoted by  $T_n$ , and Simpson's rule, denoted by  $S_{2n}$ . These are shown in Fig. 4.3. The estimate given by  $T_1$  is 0.9 and the other values have been given correct to 6 decimal places.

- (b) Complete the table in the Printed Answer Booklet, giving the values of  $M_2$ ,  $T_2$  and  $S_8$  correct to 6 decimal places. [3]
- (c) Without doing any further calculation, state the value of  $\int_0^1 (0.8x)^x dx$  to an accuracy which seems justified, explaining your answer. [1]

5 (a) Explain what problem may arise in the evaluation of  $\frac{1}{x^{10}} - \frac{1}{y^{10}}$  for large values of x and y. [2]

(b) Explain why re-writing  $\frac{1}{x^{10}} - \frac{1}{y^{10}}$  as  $\frac{y^{10} - x^{10}}{(xy)^{10}}$  may alleviate the problem identified in part (a). [1]

A spreadsheet is used to evaluate  $\frac{1}{x^{10}} - \frac{1}{y^{10}}$  for various values of x and y. The output from this spreadsheet is shown in Fig. 5. The calculation breaks down in row 7.

The formulae in cells E2 and F2 are

=D2 - C2

and =C2\*D2

respectively. Equivalent formulae are entered in the cells below E2 and F2.

(c) Write the value displayed in cell E2 using standard mathematical notation. [1]

From row 3 downwards, the values in column A have been found by multiplying the value in the cell above by 1000 and the values in column B have been found by adding 5 to the value in the adjacent cell in column A.

- (d) Comment on the behaviour of the sequence of values in column E. [1]
- (e) Explain why the same values are displayed in cells C4 and D4, but the value in cell E4 is non-zero. [1]
- (f) Explain why the value displayed in E7 is zero, even though the numerical value associated with the calculation is very large. [1]
- (g) State the meaning of the display in cell F7, explaining how it has arisen. [1]

**6** Fig. 6 shows some spreadsheet output concerning the solution of an equation, together with some further analysis. The iterates are shown in column C, the difference between successive iterates is shown in column D and the ratio of successive differences is shown in column E.
